The site is leased to an early childhood academic operator – Once Upon a Childcare – on an Absolute NNN Lease with 9 years remaining. The Lease calls for annual increases of 3% as well as 2, 5-Year options.

The property was constructed as a build-to-suit to serve as a childcare facility. It was then extensively renovated in 2022, when Once Upon a Childcare took the space, to specifically serve the needs of the operator as they continue their expansion throughout Florida.

Located across the street from Raymond James' Global HQ, the Property is strategically located within a dense residential and professional community in the Tampa-St. Petersburg-Clearwater MSA – one of the fastest growing MSAs in the country. Its centralized location is ideal for an early childhood care operation. The MSA is ranked #5 for Best Place for Young Families in Florida. Further, Clearwater has experienced an average of 11.3% population growth over the past 5 years.






Market Overview

Tampa-St. Petersburg-Clearwater MSA

The Tampa-St. Petersburg-Clearwater Metropolitan Statistical Area (MSA) is located on the west coast of Florida, known as the Gulf Coast, and encompasses Hillsborough, Pinellas, and Pasco Counties. It is one of Florida's three most commonly referred to "directional" regions – known as Central Florida, with the others being South Florida and North Florida. The area has a subtropical climate, boasting nearly 700 miles of Atlantic Ocean coastline (the Gulf of Mexico), beautiful beaches, and many major tourist attractions – promoting a comfortable lifestyle that attracts residents, businesses, and visitors from all over the world.
